PRE-HEARING MEMORANDUM

Chugach Consumers and Ray Kreig ("Chugach Consumers") submit the following pre-hearing memorandum prior to the scheduled hearing on April 20, 2007. This memorandum will briefly summarize the problems with the order.

The main problem with this order is that it is being put to a use not in the public interest. Chugach Electric is using it to interfere with the regulatory process of the Regulatory Commission of Alaska. (See Attached Motion for Return of Documents Filed Under Seal and to Strike Confidential Complaint, filed by Chugach Electric with the Regulatory Commission of Alaska, Exhibit A) The Regulatory Commission of Alaska is authorized to investigate improper conduct upon the filing of a complaint. Chugach Electric is trying to short circuit this process so that it can hide its acts. This is identical to the conduct of the cruise ship industry in trying to prevent the testimony of an injured cruise ship passenger described in the attached recent article from the Anchorage Daily News. (Exhibit B) It is only if evidence can be presented to the appropriate regulatory agencies that wrongs may be corrected or prevented.

Second, Mr. Kreig needs to retain these documents to protect both himself and the Chugach consumers. He will be keeping the documents confidential.




