Enough is enough. Chugach continues to run up costs by disregarding the Free, Open and Competitive bidding bylaw passed by 80% of Chugach voters in 1996. In 2002, it rubber-stamped, without negotiation, an extension of the bloated IBEW Union contracts (circumventing the bylaw) and now appears to want to do it again, more than a year before the contracts expire. Chugach members spoke loudly in 1996, but nothing has changed nine years later. That is not right. Unnecessary rate increases must stop. As your board member I will insist that these contracts be negotiated and modernized.

I would also reinstate the Chugach goal to be in the top ten percent of electric utilities nationwide in delivering value to its members. This would include performance measures and benchmarking to instill competition where currently there is none and assure that we are meeting our goal.
