** NOTE B - PREMATURE, NON-NEGOTIATED LABOR CONTRACT EXTENSIONS:

4/90 - Contract was extended (to 1/94) in middle of 1990 board election when it was known that more votes were cast than in any prior election. This deprived the membership of the ability for their new board to vote on the contracts during its three year term. Binding interest arbitration added 8/90.

1/93 - contract extended (one year early) to 1/98

4/02 - contract extended (one year early) to 6/06; threw away first opportunity in 13 years to negotiate a contract fair to consumers without straight jacket of binding interest arbitration. Information was suppressed to Chugach members about the issue and again it was needlessly rushed through right before an election.
